### EDAA Outstanding Dissertations Award 2019

Grenoble, February 6<sup>th</sup>, 2020. In recognition of the importance of university research to the advancement of design, automation and test, and to encourage young researchers to work in the field, the European Design and Automation Association (EDAA) has established an award for outstanding Ph.D. dissertations.

Four categories have been considered in 2019:

**Topic 1 – New directions in software design and optimization for embedded, cyber-physical and secure systems.**

**Topic 2 – New directions in system-on-chip platforms co-design, novel emerging architectures and system- level management.**

**Topic 3 – New directions in logic, physical design and CAD for analog/mixed-signal, nano-scale and emerging technologies.**

**Topic 4 – New directions in safety, reliability and security-aware hardware design, validation and test for systems and circuits**

An open call for nominations was organized. The awards are open to young researchers from any country. The dissertations must have been finalized in the last 2 years before the submission deadline. The nominations had to include - An extended statement explaining the outstanding contributions of the thesis, The PhD thesis, preferably in English, a CV and a list of related publications. Each nomination had to be supported by at least two reference letters of experts, and at least one from a different university.

In 2019 EDAA has received a total of 18 submissions from around the world. In each category, a committee of international experts evaluated all nominations and selected the final winner. Each award consists of a 1000 € prize and a certificate.

The 2019 winners have been selected by a high level jury composed by Prof. Lorena Anghel, Prof. David Atienza, Prof. Cristiana Bolchini, Prof. Alberto Bosio, Prof. Franco Fummi, Prof. Jan Madsen, Prof. Yiorgos Makris, Prof. Subhasish Mitra, Prof. David Pan, Prof. Zebo Peng, Prof. Ilia Polian, Prof. Donatella Sciuto, Prof. Olivier Sentieys, Dr. Haralampos Stratigopoulos, Prof. Mehdi Tahoori, Prof. Jurgen Teich, Dr Aida Todri, Prof. Norbert Wehn.

They will be awarded at the DATE 2020 Conference and Exhibition, to be held March 9th-13th in Grenoble, France ([www.date-conference.com](http://www.date-conference.com)).
